Ferriby reported that their geode program on the first day of summer reading was very popular and recommended it to everyone. She also announced that she will be retiring in the fall and that Miller Bradbury would be working to conduct the search for her replacement.

Werner reported that KDL has released the aptitude assessment that they have worked to develop for the last two years. It will be available to any library at the cost of \$20 per test. Contact Brian Mortimore (bmortimore@kdl.org) for information on how to get it. Lance and Brian reviewed the development of the assessment since they began working on it two years ago. It will be available to any library in the next 3-4 weeks. The tool was developed with the Performance Assessment Network and will require a library to register on their website. Once a library is registered, the test will contain the local library logo and will automatically notify applicants that they need to take the test. The library has immediate access to the test results and may determine whether to share those results with the candidate. Mortimore recommended that libraries using the test adopt a policy of not sharing the results with the candidates. The assessment is not recommended as a performance evaluation tool for existing employees. Contact Brian for more information.

Kline reported that Fennville District Library will be hosting Heather Shumaker, author of Saving Arcadia on the Michigan Notable Author Tour on June 16, 2018 at 11:00 a.m.

McNaughton reported the summer reading has begun at Grand Rapids Public Library and that the library is entering a new strategic planning process.
